Legislative Report - RHC Regulatory Reduction Bills


In September, IARHC was approached by NARHC to provide an organizational endorsement for three elements to the RHC Burden Reduction Act. Those elements included:

- Rural Behavioral Health Improvement Act to remove arbitrary 49% threshold on the amount of behavioral health services that RHCs can provide.
- Modernizing Rural PA and NP Utilization Act to update RHC physician supervision requirements by aligning them with state scope of practice laws.
- Rural Health Clinic Location Modernization Act to update the RHC statute to fix an
 issue caused by the 2020 Census, ensuring that areas of less than 50,000 remain
 eligible for RHC status.



Q2 Please indicate your type of RHC




Q3 Approximately how many people are employed at your RHC(s)?







Q7 Please rate the level of challenge each of the following issues currently presents to your RHC(s).













Q10 Which one of the following areas would provide the greatest value to your RHC? (Select one.)





Q13 How likely are you to integrate the following services into your RHC(s)?




Q14 If you are unlikely to integrate dental, behavioral, and non-medical services, what are the reasons why you do not anticipate adding those services


Q15 Which position(s) at your RHC are the most difficult to fill?







Q16 Do you utilize loan repayment programs to recruit and retain providers (i.e., National Health Service Corps, Primary Care Provider Loan Repayment Program)?





Q17 How do you currently receive updates and communication from the Iowa Association of Rural Health Clinics?





Q18 How would you prefer to receive communication from the Iowa Association of Rural Health Clinics?




